Complete and return the application with listed supporting documents to:

Your application will be processed in 2 to 3 weeks. You will be notified by letter when SurePay will be effective. You will receive a discount of \$1.00 for any bill \$5 or more.

NOTE: You should submit payment for any bill that does not include the word *SUREPAY* in the total balance due box.

The City will debit your checking or savings account 16 days after the billing date.

Any checking, savings, or utility account changes will require a new SurePay application.
